4. Sealed bids must be submitted to the **Siddharthanagar Municipality, Office of The Municipal Executive** by hand/courier **before 12.00 Noon on 2079/06/28.** Bids received after this deadline will be rejected.
5. The bids will be opened in the presence of Bidders' representatives who choose to attend at **2079/06/ 28 12.30 PM** at the office of Siddharthanagar Municipality, Siddharthanagar. Bids must be valid for a period of **90 days** from the date of bid opening and must be accompanied by a bid security amounting to a minimum of **NRs. 1,20,000.00**, which shall be valid for **30 days** beyond the validity period of the bid i.e. **2079/10/27**. If the Bidder wishes to submit the Bid Security in the form of cash, the cash should be deposited in **Agriculture Development Bank Ltd. Sidharthnagar Branch, Dharauti Account Ga-3, No. 04-146-01145634-03-8 on behalf of Siddharthanagar Municipality, Office of Municipal Executive, Siddharthanagar, Rupandehi** and submit the receipt of the deposited amount of cash along with the bid.
